1	Plastic made pre-fabricated toilet block – 4 nos block per unit.	<p>Description: SINTEX prefabricated toilet shall be suitable for mounting on readymade concrete floor/ plain ground. The components shall be fabricated at factory for easy to assembly at site. The structure shall be manufactured by using plastocrete panels for wall and pre coated GI sheets for roof, as per detailed specifications given herein.</p> <p>Wall panels: The wall shall be made with special extruded PVC Section filled with special mortar of cement and sand. The size of PVC section shall be 304.8mm and 25mm thick with suitable length for fixing groove of column. The wall panel shall be joint together by tongue and groove method. The section has eleven nos. of length wise ribs for better strength and to hold mortar in position. The PVC material shall be as per IS: 10151:1982.</p> <p>Roof Cladding: Roof cladding shall be done with pre coated galvanized plain sheets 0.5mm thickness. These shall be provided between roof and wall for air circulation as per shown in the drawing.</p> <p>Doors: Single leaf shutter shall be made out with Sintex made extruded PVC section. The thickness of shutter shall be minimum 20mm. The door shutter shall be fixed with the column with 100mm ling hinges.
